## Creation of a new plan for the Beaumont Parish Community in 2022

Our old Parish Plan ran from 2013-2018 and so the time has come to renew it.

#### What is a Parish Plan?

A Parish Plan is a community-led plan with the following purposes:

- To set out a vision of what is important to the community.
- To find out how to safeguard valued local features for the future.
- To identify key facilities and services.
- To set out any problems that need to be tackled.
- To demonstrate how distinctive character and features within the parish can be preserved.

## Why do we need a plan?

A Parish Plan helps us, as a community, to shape the future of our Parish and to influence both the new Cumberland and County Council decisions in relation to its development.

It can also be used to influence a wide range of organisations that provide services and funding to rural communities.

## **How does the Plan come into being?**

The Parish Council has set up a three-stage consultation process to ask parishioners what they would like to see in our community in the future.

- 1. A public consultation meeting was held at the Parish Hall.
- 2. A display stand was put into the Parish Hall, St Mary's Church and Monkhill Chapel to obtain responses from as many people as possible.
- 3. All the views expressed were collated and have led to the development of a questionnaire which was circulated in 2020, with very little response. We are therefore giving all households and organisations in the parish another opportunity to have a say in the future of our community.

The Parish of Beaumont covers an area defined by Bunkers Hill, Moorhouse Road, Hosket Hill, New Sandsfield, Holmes Mill, and Knockupworth and includes the villages of Beaumont, Grinsdale, Hosket Hill, Monkhill and Kirkandrews on Eden. If you live, work or own land in these areas please take this opportunity to have your say in the future of your parish by completing the questionnaire. You will be making sure that your opinions will be known and that the Parish Council will be able to continue the

development of the Parish Plan knowing that they have understood your views and have a mandate to continue.

We would like to have as wide a range of views as possible and so although we are only delivering one copy to each household, extra copies for other family members can be obtained by contacting the Parish Clerk on 01228 522540.

Please continue overleaf or on a separate sheet of paper if you would like to make your answers longer or have any other comments that you would like to make. Your completed questionnaire(s) will be collected by your Parish Councillors.

Each completed questionnaire will be eligible for entry into a prize draw for a £25 voucher to be spent on food or drink at the Drovers Rest

Any information collected in the questionnaire will be used only to assist in designing our Parish Plan and its source will not be disclosed to any third party.

## What will happen when the questionnaire is returned?

The answers and comments from each question will be analysed and used to produce a draft of the new Parish Plan with a summary of the feedback.

This draft will be available to view and for you to comment on at a Parish Meeting to be notified in the Parish Magazine. It will then be revised as necessary and agreed. A new Action Plan will be created to instruct and inform the Parish Council and other community groups as to the actions needed to further the items in the Parish Plan. The Plan and Action Plan will be shared with the City and County Councils, and any organisation identified in the delivery of the action plan, for their comment prior to publication.
